The Fund will send you a Form 1099-DIV for the calendar year that will tell you how to report these distributions for federal income tax purposes.

The Fund may make distributions of long-term capital gains more frequently than allowed pursuant to an order of exemption from Section 19(b) and Rule 19b-1 under the Investment Company Act of 1940. On a tax basis, the estimated components of the current distribution and cumulative distribution would include an estimated return of capital of \$0.1421 (48%) and \$0.1421 (48%), respectively. These amounts are estimates and the actual amounts and sources for tax reporting purposes may change upon final determination of tax characteristics and may be subject to changes based on tax regulations.
