### **ANNOUNCE RESULTS OF ANNUAL MEETINGS OF SHAREHOLDERS**

**BOSTON, MA (January 26, 2015)** – The following eight closed-end funds managed by John Hancock Advisers, LLC announced the results of their annual shareholder meetings: John Hancock Financial Opportunities Fund (NYSE: BTO), John Hancock Hedged Equity & Income Fund (NYSE: HEQ), John Hancock Preferred Income Fund (NYSE: HPI), John Hancock Preferred Income Fund II (NYSE: HPF), John Hancock Preferred Income Fund III (NYSE: HPS), John Hancock Premium Dividend Fund (NYSE: PDT), John Hancock Tax-Advantaged Dividend Income Fund (NYSE: HTD) and John Hancock Tax-Advantaged Global Shareholder Yield Fund (NYSE: HTY) (collectively, the “Funds”).

At their annual meetings held today, shareholders of the Funds re-elected Charles L. Bardelis, Peter S. Burgess, Theron S. Hoffman and Warren A. Thomson to serve as Trustees of the Funds for a three-year term ending at the 2018 annual meeting of shareholders.

The other eight Trustees of the Funds (Craig Bromley, William H. Cunningham, Grace K. Fey, Deborah C. Jackson, Hassell H. McClellan, James M. Oates, Steven R. Pruchansky and Gregory A. Russo) were not up for election and remain in office.
