**JOHN HANCOCK PREMIUM DIVIDEND FUND
NOTICE TO SHAREHOLDERS – SOURCES OF DISTRIBUTION UNDER SECTION
19(a)**

BOSTON, MA (February 28, 2023) – John Hancock Premium Dividend Fund (NYSE: PDT) (the “Fund”), a closed-end fund managed by John Hancock Investment Management LLC and subadvised by Manulife Investment Management (US) LLC, announced today sources of its monthly distribution of \$0.0975 per share paid to all shareholders of record as of February 13, 2023, pursuant to the Fund’s managed distribution plan. This press release is issued as required by an exemptive order granted to the Fund by the U.S. Securities and Exchange Commission.

Notification of Sources of Distribution

This notice provides shareholders of the John Hancock Premium Dividend Fund (NYSE: PDT) with important information concerning the distribution declared on February 1, 2023, and payable on February 28, 2023. No action is required on your part.

Distribution Amount Per Common Share: \$0.0975

The Fund will send you a Form 1099-DIV for the calendar year that will tell you how to report these distributions for federal income tax purposes.

The Fund has declared the February 2023 distribution pursuant to the Fund's managed distribution plan (the "Plan"). Under the Plan, the Fund makes fixed monthly distributions in the amount of \$0.0975 per share, which will continue to be paid monthly until further notice.
