

Calendar year returns



Class R6 without sales charge – 12/1/13 – 3/31/25





Accordingly, a security or portfolio with a 1.10 beta is expected to have 10% more volatility than the market. **10** R-squared is a measurement that indicates how closely a security or portfolio's performance correlates with the performance of its benchmark index. R-squared can range from 0.00 to 1.00, with 1.00 indicating perfect correlation to the index.

What you should know before investing

The index allocates to equities and fixed income at varying levels according to a predetermined schedule related to the respective target date.
